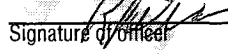
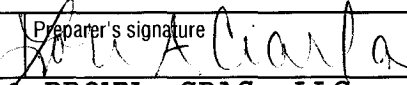

TRANSPORTATION SERVICES ARE ALSO PROVIDED. THE GOAL IS TO PROVIDE A SAFE AND NURTURING ENVIRONMENT FOR YOUTH. DURING 2012 THESE PROGRAMS SERVED 1,553 YOUTH (CHILDREN & TEENAGERS) UN-DUPLICATED COUNT. THERE WERE ALSO 10,946 COMMUNITY MEMBERS THAT ATTENDED THE EVENTS.

MANY OF OUR CLIENTS ARE THE "WORKING POOR," JUST TRYING TO MAKE ENDS MEET. BY FIGHTING HUNGER AND FOOD INSECURITY, WE PROVIDE A STEPPING STONE TO SELF-SUFFICIENCY. 10,374 PREPARED MEALS WERE SERVED TO CHILDREN AND THE FOOD PANTRY SERVED A TOTAL OF 2,777 HOUSEHOLDS WITH 4,390 ADULTS, 3,921 CHILDREN, 180 ELDERLY WITH GRAND TOTAL OF 8,491 INDIVIDUALS. WE OFFER EMERGENCY AND PERMENANT SUPPORTIVE LOW-INCOME HOUSING SERVICES FOR THESE INDIVIDUALS, WITH AN 18 BED HOMELESS SHELTER AND 33 HOUSING UNITS CONSISTING OF 1 TO 4 BEDROOM APARTMENTS. WE WORK WITH THESE INDIVIDUALS TO HELP THEM BECOME STABLIZED, MANTAIN HOUSING, COMPLETE THEIR RECOVERY PROCESS, REUNITED WITH THEIR FAMILY AND PROVIDE EDUCATION, WORK EXPEREINCE, AND CAREER OPPORTUNITIES.
